Roy: This is just saying there will be assessment to ensure they have

knowledge, details can be clarified without the vote of the student body in bylaws Sen. Schwaibold: Will the assessments for each position be different? Senate Chair: Each will be specific to each position, yes No further discussion

### Article V: Judicial Branch, Section 5: Succession, Part 2

Addition: "The Justice with the most time served in the position of Justice."

Senate Chair opens floor for discussion Sen. Saunier: Why is this one nominated? Ms. Brendan: The longer you're there, the more experience and knowledge you have in Judicial Branch, there are different roles than in the senate, everyone does the same thing, so more time served is more experience Sen. Freeman: Why not just have the President appoint a new Justice? Senate Chair: Judicial Branch is not as vigorous, they have different set up, the one who was there the longest has the most experience Sen. Pate: I think it should be based off who is most qualified Sen. Watson: Judicial branch is not set up as ours is, time is experience for them like it is for the U.S. Supreme Court Sen. Johnson: All the Justices are qualified, it should be based off experience No further discussion
